**DIRECTIONS**

**East**

**New York State Thruway - I-90 West**

I-90 west to Rt. 33 to Buffalo (first exit); take Rt. 33 to the end and exit at Oak St.; turn right at the first signal (Genesee St.) and proceed west; veer right at the first signal on Genesee (you are facing the backside of M&T Center) to Chippewa St.; cross Main St. and turn left at the next intersection (Pearl St.); head south and Bank of America is the next building. Once on Pearl, turn into the parking lot on the immediate right. From the parking lot, go to the third floor and take the tunnel across the street to the Bank of America building. Go to the double Bank of America doors and proceed to the lobby. HSE is on the 4th floor.

Alternate Route: I-90 to Rt. 33 (1st exit) to Downtown Buffalo. Stay on Rt. 33 to end and proceed to Goodell St. Stay on Goodell and after crossing Main St., veer to left following signs to Pearl St. Stay on Pearl and after crossing Chippewa St. the backside of the Bank of America is just after the Key Towers.

**West**

**New York State Thruway - I-90 East**

Follow the I-90 East to the I-190 North; you will have to pay a 75¢ toll; Exit at Elm Street; Turn left at Genesee Street; Bear right onto Chippewa Street; Turn left at Pearl Street; Park in the All Pro Parking lot, located just past the intersection of Pearl Street and Chippewa Street on your right.

**East/Northeast**

**Amherst, Williamsville, Lockport**

Take I-290 West to I-190 South. You will have to pay a 75¢ toll; Exit at Niagara Street; Turn right onto Niagara Street; Turn left at W. Huron; Parking is available at the All Pro Parking lot, located at the intersection of W. Huron and Franklin.

**Canada**

From the Peace Bridge, follow the I-190 South; Exit at Niagara Street; Turn right onto Niagara Street; Turn left at W. Huron; Parking is available in the All Pro Parking lot, located at the intersection of W. Huron and Franklin.

**North**

**Tonawanda, Grand Island and Niagara Falls**

Take I-190 South. You will have to pay a 75¢ toll; Exit at Niagara Street; Turn right onto Niagara Street; Turn left at W. Huron; Parking is available in the All Pro Parking lot, located at the intersection of W. Huron and Franklin.

## **South**

### **Hamburg, Evans, Lackawanna**

Take Rt. 5 through Lackawanna and over the Father Baker and Skyway bridges; Exit at Delaware Avenue; Turn right at W. Eagle Street; Turn left at Franklin Street; Parking is available in the All Pro Parking lot, located at the intersection of W. Huron and Franklin.

## **Southeast**

### **Orchard Park, Elma, East Aurora**

Take Rt. 400 (Aurora Expressway) to the I-90 East; Follow to the I-190 North. You will have to pay a 75¢ toll; Exit at Elm Street; Turn left at Genesee Street; Bear right onto Chippewa Street; Turn left at Pearl Street; Park in the All Pro Parking lot immediately on your right.

## **East**

### **Buffalo Airport, Depew, Cheektowaga, Lancaster, Alden**

Follow Rt. 33 West (Kensington Expressway); Exit at Goodell Street; After crossing Main Street, bear to the left (Pearl Street); Park in the All Pro Parking lot, located just past the intersection of Pearl Street and Chippewa Street on your right.
