**UNITED STATES’ NOTICE OF ELECTION

Pursuant to the False Claims Act, 31 U.S.C. §§ 3730(b)(2) and (4), the United States of America (“United States”) notifies the Court of its election to intervene in this action for settlement purposes. The United States, Defendant Seth A. Bernstein, and Relator Victoria Hablitzel have entered into a settlement agreement resolving this matter, and the United States and Relator intend to file a stipulation of dismissal shortly.

The United States also requests that the Court unseal the Relator’s Complaint, this Notice, and all other filings in this case after the date of an Order to lift the seal. The United States requests that all other papers on file in this action remain under seal because in discussing the content and extent of the United States’ investigation, such papers are provided by law to the Court alone for the sole purpose of evaluating whether the seal and time for making an election to intervene should be extended.
